- The expo center will be open and ready for all vendors to move-in on Thursday March 12th between 9am and 4pm. The promoter will make staff available during this time to answer any questions or resolve issues that may arise.
- All marked exit doors must be accessible by a 3-foot-wide aisle.
- Vendor will be held responsible for any damage they, or their employees/helpers cause to the event hall. By signing this agreement, the vendor agrees to reimburse the event hall for any damage caused by the vendor from the initial move-in day through the move-out day.
- The expo center asks that no helium balloons be sold or distributed throughout the event, however, exceptions may be made if they are attached to your display. Please make the promoter aware if your display will use helium balloons.
- Decorations may not be taped, nailed, tacked, stapled, or otherwise fastened to the ceilings, doors, floors, walls, glass, columns, painted surfaces, fabric, or decorative walls.
- If you should need to cancel this agreement, the promoter reserves the right to keep 50% of the collected funds if the cancellation occurs more than 45 days prior to the event. If cancellation occurs within 45 days of the event, the promoter reserves the right to keep all collected funds from the vendor.
- Neither the property owner, nor Central Wisconsin Expo-Event Center, nor the promoter are responsible for loss or damage to any vehicles or their contents while parked or operated on facility property.

Promoter will require 50% down upon signature of this agreement and the remaining balance will need to be paid by February 20th, 2026.
